## 1. Assistant Registrar (Examinations)

• Age: Below 45 years

Qualifications: Candidates must

• Possess a degree of Statutory University in Arts, Science, Commerce or Law and thereafter

- Possess supervisory experience for not less than 5 years in a post not below the rank of superintendent under Govt./ University and
- Possess adequate knowledge of Marathi/English so as to be able to speak, read and write.
- Preference will be given persons worked in examination branch in the University.
- Scale of Pay: Consolidated. Rs. 40,000/- p.m. (Rupees Forty Thousand Only).

### 2. Administrative Officer

- Age: Below 45 years
- Qualifications: M.B.A. (HR) or PG in HRM
- Experience: 10 years in reputed industry in relevant field as or teaching in a reputed institution.
- Scale of Pay: Consolidated. Rs.40,000/- p.m. (Rupees Forty Thousand Only).

## 3. PA/Stenographer (Higher grade)

- Age: Below 45 years
- Graduate from a recognized University.
- A speed of 120/50 wpm in shorthand and type writing respectively and with at least 7years experience as Stenographer/ PA in any reputed organization.

# **INSTRUCTIONS TO CANDIDATES**

#### GENERAL

- 1. All appointments are subject to rules and regulations of the University/ Govt. of Maharashtra framed from time to time and subject to the approval of the Executive Council of the University.
- 2. MNLU, Aurangabad is an institution of excellence and medium of instruction is English and the applicants should have good command on English language.
- 3. Number of posts advertised is tentative and subject to change.
- 4. All the above posts initially be filled for two years on Consolidated Basis which may be extended / filled on regular basis after observing their performance found satisfactory.
- 5. Mere fulfilling the eligibility conditions does not confer right on the candidate to be called for interview by the Selection Committee. A duly-constituted Screening and Evaluation Committee (SEC) will verify all applications and short-list them, before calling the candidates for interview.
- 6. Individual API scores claimed by a candidate will be substantiated by the Screening and Evaluation Committee (SEC). UGC's scale and bench-mark shall be followed. Decision of the SEC in this regard shall be final and binding.
- 7. Persons working in other Institutions and Organizations shall furnish 'NO OBJECTION CERTIFICATE' from the present employer at the time of interview.
- 8. Reservation Policy of the Government of Maharashtra will be followed. Applicant belonging to **SC/ST** categories will be eligible for relaxation of qualifying marks to an extent of 5% and age relaxation as per Maharashtra Government policy.
- 9. No application fee is payable by applicants belonging to SC/ ST/ NT(A)/NT(B)/ NT(C) and NT(D) category and differently abled. Other applicants shall pay a non-refundable application fee of Rs 1000 (Rupees one thousand) per application in the form of Demand Draft of any Nationalized Bank drawn in favor of MNLU, Aurangabad.
