ACADEMIC QUALIFICATIONS:

- An eminent scholar with Ph.D. / LL.D Degree in Law and published work of high quality, actively engaged in research with evidence of high quality published works with a minimum of 10 publications as books and / or research / policy papers.
- A minimum of ten years of teaching experience in University/ College, and/ or experience in research at the University / National level Institutions/ Industries including experience of guiding candidates for research at doctoral level.
- Contribution to educational innovation, design of new curricula and courses, and technology mediated teaching learning process.
- A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) of UGC

• An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the discipline of law, to be substantiated by credentials.

INSTRUCTIONS TO CANDIDATES

GENERAL

- 1. All appointments are subject to rules and regulations of the University/ Govt. of Maharashtra framed from time to time and subject to the approval of the Executive Council of the University.
- 2. MNLU, Aurangabad is an institution of excellence and medium of instruction is English and the applicants should have good command on English language.
- 3. Candidates applying for the post of Professor has to submit a minimum score certified by the HOD/ Institution as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) of UGC
- 4. Age of superannuation for teaching and non-teaching employees is 60 and 58 years respectively.
- 5. Number of posts advertised is tentative and subject to change.
- 6. Mere fulfilling the eligibility conditions does not confer right on the candidate to be called for interview by the Selection Committee. A duly-constituted Screening and Evaluation Committee (SEC) will verify all applications and short-list them, before calling the candidates for interview.
- 7. For direct recruitment at the level of Professors degree of Ph D is an essential qualification. Due emphasis will be on academic and research requirements as prescribed by the UGC.
- 8. Individual API scores claimed by a candidate will be substantiated by the Screening and Evaluation Committee (SEC). UGC's scale and bench-mark shall be followed. Decision of the SEC in this regard shall be final and binding.
- 9. Appointments will be made at the minimum of the scale attached to the posts. However, the Selection Committee may consider pay protection to those who are already in service. The Selection Committee may, in exceptional cases of merit to be justified in writing, recommend to the Executive Council for higher initial pay limited to maximum of three advance increments.
- 10. Persons working in other Institutions and Organizations shall furnish 'NO OBJECTION CERTIFICATE' from the present employer at the time of interview. Deputation for specific period on terms agreed between the lending and the borrowing organizations may be considered on merit.
- 11. Reservation Policy of the Government of Maharashtra will be followed. Applicant belonging to **SC/ST** categories will be eligible for relaxation of qualifying marks to an extent of 5% and age relaxation as per Maharashtra Government policy.

- 12. No application fee is payable by applicants belonging to SC/ ST/ NT(A)/NT(B)/ NT(C) and NT(D) category and differently abled. Other applicants shall pay a non-refundable application fee of Rs 1000/- (Rupees One Thousand Only) per application in the form of Demand Draft of any Nationalized Bank drawn in favor of MNLU, Aurangabad.
- 13. MNLU Aurangabad is an equal opportunity employer. All things remaining the same, preference will be given to women / differently-abled candidates as per Maharashtra Govt. Policy.
- 14. No interim query shall be entertained.
- 15. Canvassing in any manner will summarily disqualify the candidate.
- 16. No TA / DA for appearing at the interview shall be paid to candidates.
- 17. Candidates called for interview shall appear in person before the Selection Committee on the appointed date and time. Request for rescheduling the interview will not be acceded to. No virtual mode of interview (Skype, Face Time, Video Conference etc.) will be permitted.
