## GENERAL RULES FOR MOOT COURT

1. Each team shall comprise of a maximum of 3 members and a minimum of 2 members consisting of either two speakers or two speakers and 1 researcher. The number cannot be modified under any circumstances.
2. Teams shall identify the speakers and researcher during registration. No extra member or observer shall be allowed.
3. Not more than one team shall be allowed to register and participate in the competition from the same University.
4. The Moot problem and other details pertaining to the Moot Court shall be hosted on the website. Participants are directed to visit the same.

## OTHERS

1. Participants should be in Formal Attire for the competitions.
2. Our campus is No-smoking, and No-Alcohol, and we expect the participants to strictly follow the same during their stay.
3. Our University believes and promotes the **Swachh Bharat** Campaign and the participants are expected to maintain the cleanliness of the Campus at all times.
4. Facilities such as photocopying, library usage, internet connectivity, etc. may be provided subject to the convenience of the Organizing Committee and will be informed to the teams closer to the commencement of the Competition.
